

## Explorica Canada, Inc. 2016 Free Trip Giveaway Official Rules

The 2016 Free Trip Giveaway (the "Sweepstakes") begins at 12:01 a.m. EST on 1/4/16 and ends at 11:59 p.m. EST 1/7/16, (such period referred to herein as the "Sweepstakes Period"). The Sweepstakes is sponsored by Explorica Canada, Inc. (the "Sweepstakes Sponsor").

- 1. HOW TO ENTER: NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Group Leaders with three full-paying participants on your Explorica tour for departure between 1/9/2016 and 1/9/2018 will automatically be entered to win. You will receive one entry into the drawing for every three full-paying participants that enrol on your tour between 12:01 a.m. EST on 1/4/16 and 11:59 p.m. EST on 1/7/16. Participation in the Sweepstakes is voluntary and does not require you to purchase anything from the Sweepstakes Sponsor. To enter by mail, print your first and last name, complete address, city, province, postal code, daytime telephone number, date of birth, and e-mail address (if available) on a three-by-five-inch card. Put the card in an envelope, affix first-class postage, and send it to the Sweepstakes Sponsor with attention to 2016 Free Trip Giveaway. No illegible, incomplete, forged or altered entries will be accepted. All entries must be received by the last day of each month during the Sweepstakes Period. One entry per person. Mechanically reproduced entries not accepted. All entries become the property of the Sweepstakes Sponsor and will not be returned.
- 2. **PRIZE**: The Sweepstakes Sponsor will award up to 10 prizes during the Promotion Period. The winners who are leading a Qualifying Tour will be awarded a free spot on that tour to apply to any current or future traveller (if applied to a current traveller, s/he will receive a refund of any amount of the tour program price as of that date). Any Tour Leader not already enrolled on a Qualifying Tour will receive a travel voucher for up to \$4,500 that may be redeemed for any available tour operated by Sponsors departing between September 1, 2016 and September 1, 2018. The prize does not include and cannot be applied to any optional excursion fees, insurance fees, money for gratuities, or discretionary on-tour expenses. In the event the winner does not accept the prize, the winner is ineligible, or the prize or prize notification is not deliverable an alternate winner may be selected.
